

# ***Training Programme on Intellectual Property Rights (IPRs) and Related WTO Issues***

*Jaipur, November 3-7, 2008*

## **Context**

In this age of globalisation and increasing harmonisation of rules and practices for multilateral trade, investment and intellectual property rights (IPRs), participants in economic activities need to stay abreast of developments in many areas including the World Trade Organisation (WTO) rules. This applies equally to scientists and technologists working in various capacities in the Government of India.

Global rule making in the area of intellectual property was primarily in the domain of the World Intellectual Property Organization (WIPO) until a decade back. The Paris Convention (1967), the Berne Convention (1971), the Rome Convention (1961) and Washington Treaty (1989) of WIPO governed cross-border disciplines for intellectual property. While these treaties have been ratified by many countries, their implementation and enforcement left much to be desired. The emergence of the WTO in 1995 and the inclusion of the Agreement on Trade Related Aspects of Intellectual Property Rights (TRIPs) under its *acquis* has obliged members to follow a set of uniform minimum standards in IPR protection.

The WTO TRIPs Agreement has the objective of protecting and enforcing IPRs in order to contribute to the promotion of technological innovation and transfer and dissemination of technology to the mutual advantage of producers and users of technological knowledge in a manner which is conducive to social and economic welfare and to a balance of rights and obligations.

In this context, women are comparatively more at risk of being left in a disadvantaged position in many societies. Structural inequalities between men and women in terms of access to resources such as land, credit and technical assistance require particular sensitivity in the area of IPRs to enhance the welfare, efficiency, equality and empowerment of women and to ensure gender equity. The patriarchal system, leaving women in the informal sectors of the economy with their innovations being unaccounted for and excluding them from social decision-making processes has to be challenged on all levels if the intellectual heritage and property of women is to be secured.

The universe of IPRs in the WTO TRIPs Agreement comprises of patents, copyright and related rights, trademarks, geographical indications, industrial designs, patents, layout designs of integrated circuits and trade secrets. While scientists would benefit from an exposure to the basic rules pertaining to all these IPRs, patent and copyright protection with regard to women's interests is of particular relevance to their functions of innovation and applied research.

This programme is aimed to facilitate an overview of the basic principles of multilateral trading system enshrined in the WTO and an understanding of the trade rules that apply to IPRs under its TRIPs Agreement. It will develop the capacity of Indian scientists and technologists to better exploit the opportunities that arise from the use of IPRs and sensitise them on IPR issues of particular relevance to women.

### **Objectives**

- To meet the imperative of having trained scientists/technologists in various departments of the Government of India who are involved with IPR issues; and
- To enhance skills by developing/strengthening capacity for taking effective part in the IPR regime in India and in others parts of the world

#### ***An overview of the WTO***

Emergence of the new multilateral trade order - from GATT to WTO, understanding of the process, mechanics, key aspects, approaches of multilateral trade negotiations, etc

#### ***Linkages between trade and gender with a focus on IPR issues***

Meaning of gender, relationship between gender and trade, gender and IPR issues

#### ***An overview of the WTO TRIPs Agreement***

General features and forms of intellectual property, structure, components and principles of the WTO TRIPs Agreement

#### ***Enforcement under the WTO TRIPs Agreement***

Requirements containing the WTO TRIPs Agreement relating to enforcement of IPRs at national level, existing domestic enforcement framework on IPRs, emerging issues in global IPR enforcement

#### ***Current negotiations on the WTO TRIPs Agreement***

An overview of ongoing negotiations in the WTO in context of the TRIPs Agreement and relationship of these negotiations with ongoing work in World Intellectual Property Organisation and other organisations

#### ***Patents in the WTO TRIPs Agreement and the Indian law***

An overview of provisions of the TRIPs Agreement and corresponding Indian legislation on patent and the protection of plant varieties and farmers' right

#### ***Trademarks and copyright laws in India***

*An overview of provisions in the WTO TRIPs Agreement and corresponding Indian legislation on trademarks and copyrights*

### ***Patent protection and the Indian agriculture sector***

Major issues that concern IPR in agricultural research and development in India such as issues of patents and *sui generis* IPR protection system in agriculture and the way forward

### ***Relationship of IPRs with biotechnology***

The importance of biotechnology and plant varieties protection given the demand for increase in agricultural productivity

### ***Traditional knowledge and access and benefit sharing***

The importance of traditional knowledge and access and benefit sharing given the rich heritage of culture and biodiversity in India

### ***Patent drafting and filing***

The conceptual and practical aspects of drafting and filing patents including drafting of descriptions and claims, compliance with procedural requirements and skills required while interacting with potential investors

### ***Simulation exercise on drafting of a patent application***

Participants will be taken through all the steps from the conception of a patentable subject matter to the successful filing of a patent claim before a patent office

### **State of the Art**

A series of interactive sessions will be conducted by a team of eminent and experienced resource persons. They include: lectures, case analysis, simulation exercises and group discussions. It will provide strategic understanding, develop core skills, and encourage in-depth knowledge of the dynamics involved in IPRs and related WTO issues.
